The mission of the Sports Tribunal is to ensure that those involved in a sports dispute have access to a fair, objective and just means of resolving their disputes in a way that is also affordable, timely and efficient.

The lawyers in this Legal Assistance Panel list (**Panel Lawyers**) have expressed an interest in providing legal advice to those involved in sports disputes.

### Fees

To support the Tribunal's mission, many Panel Lawyers have provided their services to people at a reduced fee or pro bono (free/no cost). However, there is no obligation on them to do this.

You should discuss your situation and agree with your lawyer a fee that is acceptable to you (e.g., a maximum amount, an hourly rate, at no cost) before you engage them to provide legal advice. You should also make sure that anything you do agree with them about the fee is recorded in writing (e.g., in an email).

The Tribunal ultimately has no bearing on what Panel Lawyers charge.
